A part time CFO was engaged to support RFL to manage and put up-to-date budgets Into place.

With the assistance of partners, three strategic planning sessions were facilitated with the BOD to analyze efforts that had been effective and establish what the goals of the organization should be going forward.

Tampa Bay Healthcare Collab

Development of a strategic plan for the launch of a community collaboration app to enable the organization to pivot during the pandemic and continue to serve the community. After the successful launch of the app, SVP partners re-engaged with TBHC to develop creative Ideas for revenue generation from the app.

Saving Our Seniors

Saving Our Seniors as been working towards are locating a warehouse space in order to gain additional licensing, creating strong operational infrastructure, and implementing an inventory system to be able to resell surplus durable medical equipment for additional revenue streams to her organization.

The Skills Center

The facility will offer a unique "Service Model" that will house 5 experienced youth serving organizations in a coordinated approach to leverage resources, programming and funding. This state of the art, multipurpose Center will encompass a wide range of programming, sports and events. SVP partners worked with TSC to iron out initial planning, then introduced Capex Advisory Group into the project. SVP will continue to gather updates from Capex as well as The Skills Center as they navigate their path to their new space.
